#### **Stella Maris Notices**

Greetings Dear Parishioners of Stella Maris Catholic Church, and to friends of our Parish As we continue to celebrate the risen Christ, amid the beginnings of spring, a new life is emerging for all of us. From this day forward we will be called upon to make sacrifices and to help each other as we, and the world, grapple with life threatening virus' and the effects they cause. Our future will look very different when this current pandemic has been eradicated. Prior to Covid-19, we took for granted our parish family would be able to gather in prayer, in the house of the Lord, without fear for our health and well being. Now, however, the reality of a "Global Pandemic" dictates how we may gather in the future.

Since the advent of Covid-19, Stella Maris has joined churches of all denominations through-

out Canada by discontinuing to celebrate mass as per usual. To date churches have offered online services via television or other forms of media. While there have been no liturgical celebrations in Stella Maris Church, our doors have and will remain open daily from 10:00am to 5:00pm for individual worship or to access the Knights of Columbus "Food Bank" located in the back of the church on the main level. As directed by PEI's health officials, social distancing is strongly encouraged when accessing the Church or Food Bank. It should be noted the food bank is well stocked with food and supplies available to those in need.

The Knights of Columbus Food Bank is able to offer this assistance through donations of food and money from generous parishioners, as well as from friends of Stella Maris Parish, St. Augustine's Parish and St. Anne's Parish who live outside our Pastoral Unit.

To our parishioners and friends, while Covid-19 has put a halt to most business pertaining to the operation of our parish, there are still bills to be paid. Our church survives primarily through funds received from Sunday collections, and supplemented through special fundraisers and other donations. With our inability to gather as a church family, so has our ability to hold fundraisers or to offer a collection plate to help maintain our church and grounds. Understandably, our current economic situation dictates whether or not you are in a position to continue to contribute with your weekly collection envelope. If you are able, please forward your contribution to any member of the Property and Finance Committee or mail your contribution to Stella Maris Catholic Parish Church - PO Box 7, North Rustico, PE COA 1XO. Again due to the Covid-19 pandemic, this year our Annual Parish Collection will be postponed so as not to impose an extra burden on parishioners during this time of economic uncertainty. However, if you are able, and wish to make an additional special offering to our parish church, your faith gesture will be greatly appreciated.

As many are aware, there is an effort within our community to build a new rink and fitness centre to be located on land adjacent to our church. A portion of that property is presently under title to Stella Maris Parish. Previously, this 1.40 acre parcel of land has been used for recreation purposes, including baseball and is located between our church and the present day North Star Arena. This extra piece of land is needed in order to accommodate the proposed Centre. In order to move forward on this initiative, it is imperative for the organizing committee to have free and clear title to the 1.40 acre parcel of land in question.

Your Property and Finance Committee has expressed their approval for this land transfer, thereby allowing for progress to continue on this project. It is the Committee's feeling such cooperation will benefit the community at large, while at the same time have little effect on our Church family.
