## A Pastoral Letter to the People of the Diocese - June 8, 2020

Dear brothers and sisters in Christ,

Peace and grace of our loving God be with you!

These past few months have been difficult for all of us. I share your heartache that we have not been able to gather for Sunday Eucharist. The recent approval to come together for weekday Eucharistic celebration limited to 15 people is only marginally helpful. I want you to know I have laboured hard to seek agreement to re-open our churches for fuller participation especially on Sundays.

Over the past month and a half, I have communicated with the Chief Public Health Officer and/ or her deputy, as well as writing to the Premier. I have prepared a detailed Safety Protocol to ensure that we could come together in a safe manner. I have advocated that we be allowed to gather for Sunday worship up to a maximum of 30% capacity of our churches. Unfortunately, despite the Public Health Office acknowledging that our Protocol was the "most rigorous" of those received, the dialogue with the province has not been fruitful. Public Health Officials seem determined to impose a fixed number (50) as an upper limit in Phase 4 . For small churches fifty in attendance may be adequate but not for larger churches such as St. Mary's, Souris, St. Simon and Jude, Tignish, St. Paul's, Summerside and all the churches in Charlottetown.

My experience in trying to present a realistic approach to Sunday worship, during the "new normal", leads me to question just how important a person's faith is seen by the government officials. Is it as important as economic opportunity i.e. re-opening restaurants? Is it as important as re-opening sporting activities and barber shops? Is it as important as opening our borders to seasonal dwellers?

The truth is, as you know, that our faith and the ability to actively celebrate it has significant implications for emotional and psychological well-being. Stated simply celebrating faith together has health benefits! Mandating that faith communities gather in relatively small numbers is divisive. That is, it divides a community, forcing the doors of the church to be closed to many more than are able to enter. This does not strike me as just or reasonable.

If assemblies of worship are able to adhere to Health directives (of sanitizing, social distancing, no clustering of people coming and going, and minimizing any physical contact in receiving Communion etc.) why is it untenable that faith communities be able to function in numbers that are communally acceptable? I am confident that parishes can meet the health standards with 30% in attendance; and all the while collecting personal data from participants to facilitate effective tracking and tracing.

I want to assert that faith communities have a right to function, and to function well. I want to protect our people and keep them safe as much as the Public Health Officials. Yet I believe that the Province of Prince Edward Island, given its unique situation in controlling Covid-19, needs to be more open and understanding of faith communities of all types who long to gather for worship in their churches.

## **Blessings Fellow Parishioners**,

Time is quickly passing and it is hard to believe it has been almost 3 months since we have come together to worship. As we begin the next phase of opening things up, permission has been granted to resume weekday masses. Of course like everything else, there are restrictions, guidelines and proper protocol that must be followed and adhered to. We ask for your support and patience as we begin to implement our operational plan. PLEASE NOTE this plan may change frequently in order to accommodate our parishioners, while adhering to the guidelines as implemented by our Diocese and Health PEI. We have agreed to begin with 5 weekday masses to see how things go and if the need arises Fr. Raj is prepared to celebrate more masses with us to accommodate as many as possible. There will be 2 held in St. Augustine's, 2 in Stella Maris and 1 in St. Anne's. In the interim for the morning mass, we ask that our parishioners restrict themselves to only attend at their respective church they would normally attend for Sunday Worship. So if you attend Sunday Morning Mass in St. Anne's then you would have the opportunity to attend the scheduled weekday mass in St. Anne's, the same for Stella Maris and St. Augustine. The only exception is the Weekday evening Mass. Parishioners from all 3 churches will have the opportunity to attend.

At this time, permission has only been granted for indoor mass: therefore, we are restricted to the maximum limit of 15. This includes Fr. Raj. With the limited restricted amount, and if numbers warrant, a schedule may have be set up to accommodate all. Until we have an idea of how many would like to have the opportunity to attend, please be kind and patient with us and fellow parishioners as we work together ensuring all have an opportunity at some point to come together with others to Worship God. It is very important to protect yourself and other Parishioners; therefore if you are not feeling well, please stay home. If you are at an

increased risk due to a compromised immune system and/or have underlying medical conditions, we strongly encourage you to please stay home. Those who are self isolating are asked to refrain until you have been completed your 14 day isolation period.

When you arrive physical distancing MUST be maintained. Keep the required 6 feet distancing between you and your fellow parishioner. Unfortunately no handshaking or hugging permitted. PLEASE NOTE: in order to ensure proper sanitation is maintained, only one entrance will be utilized. You will be greeted by a fellow parishioner who will be recording your name and number. They also will provide you with some hand sanitizer. All books have been removed. Pews and the floors have been marked off to ensure we maintain physical distancing. Please respect these markings. When you depart, please maintain social distancing. It is imperative we follow these guidelines to ensure the continuation of weekday masses. For your reference, please see below a compiled list of the rules stipulated by the Diocese and Health PEI.

This is the new norm for all of us; therefore, please understand we are all working together to ensure all of our parishioners needs are met to the best of our ability within the restrictions provided. As stated above this plan may change on short notice so we thank you in advance for your patience and support

• Limit the size of the gathering to no more than 15 people indoor, and 20 people outdoors, including staff and volunteers; follow guidance on gatherings.

• Advise people who are self-isolating or with COVID-19 symptoms to stay home.

• Implement measures to reduce physical contact; physical distancing must be maintained at all times between individuals from different households.

• No handshaking or hugging.

• Seating should be arranged or marked to ensure social distancing (e.g. some rows of pews may not be able to be used).

• Stagger arrival and departure times and use visual cues like floor markings to encourage two metre (six feet) physical separation through corridors and entrances/exits.

• Multiple people should not touch the same object, such as tongs, a cup, a font, or collection.

• Avoid providing attendees with shared items that cannot be easily cleaned and sanitized between use, such as books and programs.

• Any person who may be within six feet of another person outside of their household . Print and post signage to notify individuals should wear a non-medical mask, and practice that they should not attend if they have symphand hygiene before putting on the mask and toms of COVID-19, including fever, chills, before and after removing the mask.

- Respiratory etiquette (coughing and sneezing), and
- Cleaning and disinfection practices and expectations.

As directed by PEI's health officials, social distancing is strongly encouraged when accessing the Church or Food Bank. It should be noted the food bank is well stocked with food and supplies available to those in need.

The Knights of Columbus Food Bank is able to offer this assistance through donations of food and money from generous parishioners, as well as from friends of Stella Maris Parish, St. Augustine's Parish and St. Anne's Parish who live outside our Pastoral Unit.

To our parishioners and friends, while Covid-19 has put a halt to most business pertaining to the operation of our parish, there are still bills to be paid. Our church survives primarily through funds received from Sunday collections, and supplemented through special fundraisers and other donations. With our inability to gather as a church family, so has our ability to hold fundraisers or to offer a collection plate to help maintain our church and grounds. Understandably, our current economic situation dictates whether or not you are in a position to continue to contribute with your weekly collection envelope. If you are able, please forward your contribution to any member of the Property and Finance Committee or mail your contribution to Stella Maris Catholic Parish Church - PO Box 7, North Rustico, PE COA 1XO. Again due to the Covid-19 pandemic, this year our Annual Parish Collection will be postponed so as not to impose an extra burden on parishioners during this time of economic uncertainty. However, if you are able, and wish to make an additional special offering to our parish church, your faith gesture will be greatly appreciated.

As many are aware, there is an effort within our community to build a new rink and fitness centre to be located on land adjacent to our church. Your Property and Finance Committee has expressed their approval for this land transfer, thereby allowing for progress to continue on this project. It is the Committee's feeling such cooperation will benefit the community at large, while at the same time have little effect on our Church family.

# My flesh is real food and my blood is real drink

# The Word This Week

The Eucharist the Body and Blood of Christ is a mystery with so many layers and a depth that takes more than a lifetime to penetrate. It is not just a thing that we receive however reverently it is a person, a relationship, a belonging and a transformation that we consume, that becomes part of us: Receive what you are the Body of Christ. The readings invite us to reflect on how our celebration of the Eucharist brings Christ's words to our reality: who eats my flesh and drink my blood lives in me and I live in him. The people of the Old Testament had God living in their midst, walking with them on their journey, feeding and nourishing them with the gift of manna from heaven. Jesus walks with us, not looking on from afar, journeying in communion with us living within us, as we eat and drink the gifts he extends from the Last Supper. And as Saint Paul reminds us, our communion with the One Christ is also a communion with each other God lives in us as the Church, as we become His Body.
